#### **FUND OBJECTIVE & STRATEGY**



In selecting investments, the Adviser focuses on companies that it believes to be undervalued or otherwise out-of-favor in the market, but that have attractive growth prospects.

### 20 Year Risk and Return




# Sector Exposure (% of Equities)
